This application form is **NOT** to be used when requesting CCTV footage that has been seized as part of an investigation. For further information in relation to your request, please do not hesitate to contact us.

An application fee of \$115.00 will apply. If the footage is required for civil proceedings no fees will apply, however evidence of such proceedings will need to be included with the application.

Please note that most footage is only held for 30 days before being destroyed.

Please send your completed application form, a clear copy of your photo ID and proof of payment to the Information Access Team by email or mail. If you submit your form at an NT Police Station, the receiving officer will verify your ID and forward your application to the Information Access Team for you.
