Complete Traffic History Checks attract a fee of **50 Revenue Units** per application. Revenue Units are governed by the Northern Territory *Revenue Units Act 2009* and are subject to change 1 July each year.

The Northern Territory Department of Treasury and Finance determine the value of a Revenue Unit for all Northern Territory Government Departments.

Please refer to our agency's current Fees and Charges if you are unsure of the fee associated with this request.

Unfortunately, these fees can **NOT** be waived under any circumstances.

You must sign this form in the presence of an authorised officer. A copy of your photo ID will also need to be endorsed by an authorised officer and attached to this application. Authorised officers are NTPFES employees, interstate police officers, a Justice of the Peace or a Commissioner of Oaths. If you submit your application at a Police Station in the Northern Territory, the receiving officer will certify your ID and forward your application to the Information Access Team for you.

Please note that we can only check your history from the **Northern Territory**. If you require a check from another State or Territory, you will need to apply to that jurisdiction directly.
